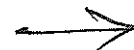

ORDER

In the Bye Election, 2025 to Nilambur LAC, a number of personnel from Central and State Government employees have to be appointed as Designated Officers and constitute teams which have to work from the date of Notification of Election to the date of poll, continuously. Following are the categories of Designated Officers and teams engaged during the period:

(e)	Video Surveillance Team
(f)	Video Viewing Team

(h)	Static Surveillance Team (SST)/ Video Surveillance Team (VST)
(i)	District Control Room
(j)	Anti Defacement Squad
(k)	MCC Team
(l)	Sectoral Officer
(m)	Sectoral Assistant



(n)	Zonal Magistrate
(o)	Expenditure Monitoring/Control Room
(p)	Income Tax Team of Income Tax Department

2) Taking into consideration of the nature of work done by the above said categories, Government are pleased to accord sanction for the remuneration as follows, irrespective of the category or team they are engaged. The amount mentioned in the following table is for the whole duty. In case of any Designated Officers or team members who have worked for a lesser period, they shall be paid proportionately.

Category	Amount (whole duty)
Employees classified under Group - A	Rs. 7,500/-
Employees classified under Group - B	Rs. 6,000/-
Employees classified under Group - C	Rs. 4,000/-
Employees classified under Group - D	Rs. 3,000/-

3). The Assistant Expenditure Observers who are in the rank of 'Group B' Officer or equivalent in other Central Government services, Election Commission of India recommends that Rs. 7,500/- (Rupees Seven Thousand Five Hundred only) as the minimum rate of honorarium/remuneration to be disbursed to each Assistant Expenditure Observers for his/her full time election duty and for partial duration on pro rata basis.

4) Guidelines on classification of Central Government employees and classification of State Government employees issued by Department of Personnel and Training, Government of India and State Government shall be followed for deciding the Group of Employees. All the Staff including drivers (excluding the employees engaged on contract basis) in the team mentioned in Para - 1 shall be eligible for remuneration.

5) The above Officers may be paid Rs. 250/- (Rupees two hundred and fifty only) per day as refreshment charges/food allowance.

6) Remuneration to the Executive Magistrate (Strong Room),

Police - Fire & Rescue Team, Police Personnel in various Team/Squad are as follows:

(i) Executive Magistrates:

Executive Magistrates deputed for EVM Strong Room duty from the Date of Polling (19.06.2025) to the Date of Counting (23.06.2025) continuously shall be paid Rs. 600/- (Rupees Six Hundred only) per day or the amount mentioned in the second paragraph above, **whichever is less** as Remuneration. In addition, Rs. 250/- (Rupees two hundred and fifty only) per day will be paid as food allowance.

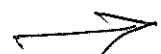
(ii) Police/Fire & Rescue Personnel in Strong Room Duty:

The Central and State Police forces have been deployed as part of the '*Bundo Bust*' duty to maintain law and order during the election period. Since the *Bundo Bust* duty is part of law and order, the Police and Fire & Rescue Service personnel who are assigned to the duty shall be paid remuneration from the Police Department as in the previous elections. Those personnel who are engaged for election duty from the date of polling (19.06.2025) to the Date of Counting (23.06.2025) are eligible for Rs. 250/- (Rupees Two Hundred and Fifty only) per day as food allowance from the Election section.

(iii) Police Personnel engaged for election duty in various team/squads:

The remuneration to the Police Personnel deputed in various team/squads in connection with the election shall be paid from the Police Department. They are eligible for Rs. 250/- (Rupees two hundred and fifty only) per day as food allowance from the Election section.

7) The District Election Officers concerned shall issue an order for appointing the Officers with Name of the Employees, PEN/Employee Code, Department, Office etc. The details of Name of Employees, PEN/Employee Code, Department, Office,

Details of Posting Order, Date of Duties, Relieving Order, Mobile Number, Banks account details with IFSC, Branch etc. should be recorded in the relevant duty registers maintained by the District Election Wing.

8) While sanctioning remuneration/food allowance an acquittance shall be prepared incorporating the details i.e. Name, PEN / Employee Code, Designation, Office, Mobile Number etc. of the employees.

9) The employees who receive food packets are not eligible for food allowance.

10) The expenditure in connection with the Nilambur LAC Bye election shall be met from the H/A '2015 - 00 - 106 - 99 - 34 - 3 - Other Charges'.
