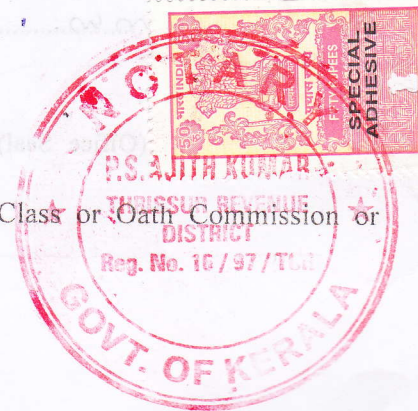

NOTE

1. In Schedule 5:—
