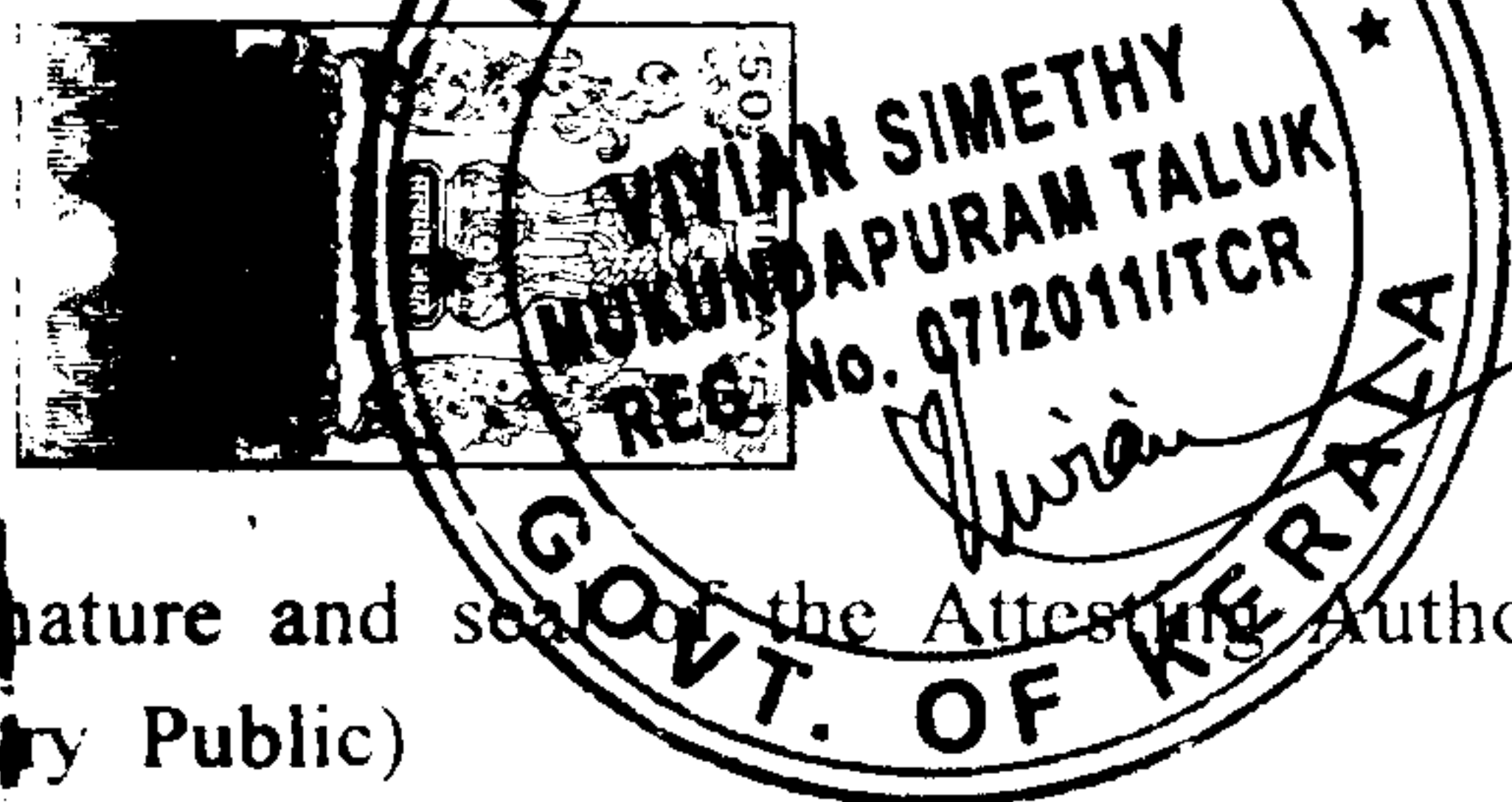



1. In Schedule 5:—
