With reference to the above ,may I submit the following for your kind consideration and necessary action.

- The statement showing reconciliation of expenses is far from truth, conviction and correctness. It is disputable and hence am not agreeing with your Inspection committees findings.
- The date from which the expenses have been calculated is absent in the statement.
- The amount shown on items of wall posters and wall writings is irrational and unjustifiable and hence totally unacceptable.
- 4) The expenditure shown on flex boards, temporary committee offices, chairs, loud speakers, dangles, sound mike announcement, podium and conventions are also disputable and hence it is unacceptable.
- 5) I am giving below item wise details of day to day expenditure for 21 items shown in the reconciliation statement

Sl No Item

<u>Wall Poster</u>: A sum of Rs 14,88,348/, is shown as expenditure for wall posters, by your Inspection committee

But we have printed only 80,000 posters of single demy and double demy size. The total cost of the same covers to Rs 2,24,000/. The same is shown in our day to day accounts of 28^{th} March 2014 and the Bill nos 3628 dt 13/03/2014, 3645 dt 14/03/2014 and 3737 dt 26/03/2014 for Rs 2,24,000 presented on 28/03/2014 have been paid by cheaque No 366481 of IOB Vazhuthacaud Branch dt 28/03/2014

The amount shown by the election expenditure Inspection committee is exceedingly high and disputable. It is not acceptable.

Hence, the above shown amount of Rs 2,24,000/, may be recorded as the actual amount spent as it is reflecting the true position Sl No_____ Item

2 <u>Wall Writing</u>: A sum of Rs 33,11,102/, is shown as expenditure for wall writings, by your Inspection committee.

The candidate has filed his nomination paper only on 19/03/2014 and orders were placed for wall writing only there after.

For the seven Legislative Assembly constituencies of Attingal Parliamentary constituency following is the pattern of expenditure

Our party is a cadre party and our members are not doing the work for any remuneration. Their labour is a service and that cannot be accounted for expenditure of the candidate.

Hence the total amount spent on wall writings may please be revised as Rs. 3,60000/-

Copies Vouchers received from seven LAC Secretaries are enclosed herewith for your perusal

In these circumstances please revise the amount of expenditure incurred on wall writing as Rs3,60000/-

Sl No Item

- 3 <u>Cloth Banner:</u> We are not using any cloth banner. Hence the amount of Rs 1,466/- shown as expenditure on this a count may please be deleted.
- Flex Banner:-We are using only flux boards and the amount shown as Rs 2,50,000/- under this head may please be trusfered under the head Flux Board and the amount of expenditure shown under this head may be deleted
- 5 <u>Flex Boards</u>:-Your inspection Committee has arrived at an amount of Rs. 12,25,494/- towards the cost of Flux Boards. This amount is very exorbitant and far from truth.

The actual amount spent for Flux Boards is only Rs. 5,00,000/-covering all the seven Legislative Assembly Constituencies of Attingal Parliament Constituency.

Hence, the discrepancy may please be done away with and Rs. 5,00,000/- may be recorded as the actual expenditure incurred for Flux Boards.

6 Committee Office:- The Inspection Committee has recorded a sum of Rs. 2,25,845/- as the amount for constructing temporary offices.

We have constructed temporary offices/ booths at 470 place @ Rs. 1,000/- per booth.

The Attingal Parliamentary Committee Office expenditure comes to Rs. 6,000/-

The figures may recorded accordingly.

7 Flag:- Your Inspection Committee has arrived at a figure of Rs. 18,742 /- as charges for Flags.

Sir, no order has been placed for flags and hence, no amount has been spent on account of this.

Hence, expenditure on this account may please be deleted.

8 Chairs:- We have not hired any chair from anywhere. The chairs are provided by our members from their homes.

As no order has been placed for hiring chairs, the amount of Rs. 70,065/- shown as rent for chairs may please be deleted.

- 9 Table: Like chairs, table is also not hired by us. Hence an amount of Rs. 300/- shown as expenditure may please be deleted.
- 10 Loud Speaker:- A sum of Rs 8,400 /- is shown as expenditure for loud speaker.

But we have actually paid only a sum of Rs. 1,000/- as rent for loud speaker.

Hence, the expenditure on this account may please be limited to Rs. 1,000/-.

11 <u>Dangles:</u>- A sum of Rs 4,233 /- is shown as expenditure for dangles.

Dangles is set up only as an added attraction to the stage. Hence, the stage makers are not including this amount in their bills, for us.

So Rs. 4,233/- shown as expenditure on this account may please be deleted.

12 <u>Vehicles</u>:- Permission for plying vehicles have been obtained from different places in the constituency with effect from 25/03/2014.

Only on obtaining full details from different places the actual amount could be arrived at. Till then this item maybe kept in pending.

I am enclosing here with the copies of vehicle permission for your kind perusal.

Sound:- The Inspection Committee has assessed an amount of Rs. 77,400/- towards sound. But our well-wishers are providing us sound system for a token amount of Rs. 1,200/-

Hence, the actual amount spent by us may be calculated as the amount spent and the amount shown by the Inspection Committee revised.

14 <u>Convention</u>:- The Inspection Committee has assessed a sum of Rs. 1,51,348/- as expenditure incurred for convention.

It may please be noted that only 5 public meetings have taken place after filing Nomination Paper on 19.03.2014 and the expenditure incurred is shown on the day to day expenditure columns of 26.03.2014 and 29.03.2014.

5.The amounts shown on wall poster, wall writing, flex banner, flex boards ,flag,chairs,table,loud speaker,dangles,sound,convention,notice,arch,podium are absolutely arbitrary and with out any proper or rational calculations.

6.May I request your good self,to direct the Inspection Committee Members to provide us the split up details of wall poster and wall writing in the seven legislative assembly constituencies for cross checking. The details collected by shadow observers on day today basis may be provided to us with evidence, for verification.

7. Now, I am giving below item wise details of day to day expenditure as per descriptions given in the reconciliation statement.

SI. No: Description

 Wall Poster: The expenditure shown on wall poster is not reflecting a true and correct picture. We have already submitted the details, in response to your first and second notices.

The amount shown as Rs 14,92,842/- is absolutely in correct, un-justifiable and un-acceptable.

Hence the above figure may please be re-calculated in a scientific manner. Till then the amount shown now may be kept in abeyance.

 Wall Writings: The expenditure shown for wall writing is again unscientific and in correct. Your Inspection Committee Memebers have been showing figures, which are totally un-true and un-acceptable.

The actual amount spent for wall writing is only Rs 3,60,000/-.

We are getting the work done free of cost by our party members.

We have already submitted vouchers to the actual amount spent for wall writings.

Wall Writing is over by 30/March/2014. But the Inspection Committee Members are in corporating more and more amounts in the statements with out any proper and fool proof verification.

 Cloth Banner: No cloth banner is used by us. Hence, the amount of Rs 2046/may be deleted.

- 4. Flex Banner: We are using only Flex boards and no amount is spent on Flex Banner. Hence, the amount of Rs 2,50,000/- shown as expenditure by the candidate, on this head, may please be transferred under the head flex board.
 - Flex Board: No amount has been spent on account of flex boards during the period 01/04/2014 to 04/04/2014.



Hence the amount of Rs 19,59,063/- shown as expenditure for flex boards may please be deleted and the actual expenditure of Rs/-5,00,000 be accepted.

 Committee office: Construction of temporary Committee offices/Booths were done w.e.f 20/03/2014 to 28/03/2014.

A total number of 470 Committee offices where built and a total sum of Rs 4,70,000/- has been spent on this account. Hence, the amount shown as above may be incorporated in your office records.

Flag: An amount of Rs 30,057/-is shown as expenditure for flags.

But no order has been placed for flags. Hence, the amount shown above as expenditure may please be deleted.

- Chairs: No chair has been hired from anywhere .Hence, the amount of Rs 84,121/- shown as hiring charges for chairs may please be deleted.
- Table: Table is also not hired by us. Hence, the expenditure shown may be deleted.
- 10. Loud Speaker: During 01/04/2014 to 05/04/2014, twenty three public meetings have taken place and a sum of Rs1,15,000/-has been spent on this account.

The amount shown by the Inspection Committee Rs 2,92,426/- is absolutely un scientific and hence objectionable and un acceptable.

- Dangles: A sum of Rs 6,453/- is shown for dangles. Dangle is only an added attraction to the stage. Hence, the stage makers are not including this amount for us in their bills.
- 12. Vehicles: Details of Vehicles plying for the days w.e.f 25/03/2014 to 05/03/2014 has been shown in the day to day expenditure account, and a sum of Rs5,22,000/- is shown as the actual expenditure on this account. Hence, this item may be kept in pending till final accounts are submitted.
- Sound: The Inspection Committee has shown an amount of Rs1,70,854/- as expenditure on this account. Our well wishers are providing us sound system for a token amount

of Rs 1,200/-.Hence,the amount may be suitably revised corresponding to the number of meetings that had taken place.

14. Convention: No convention had taken place during the period 01/04/2014 to 05/04/2014. But 23 public meetings had taken place till 05/04/2014 and a total sum of Rs 1,15,000/- has been spent on this account.

Hence, the amount of Rs 20,95,557/-shown as expenditure for convention may please be revised to Rs 1,15,000/-

- Notice: The expenditure shown for notice by the Inspection Committee is Rs 3,21,892/-.But we have spent only Rs 1,40,000/-so far on this account. At the time of final settlement of accounts, the actual amount spent on this account will be recorded. Till then, the amount may be please kept in pending.
- 16. <u>Mike announcement:</u> The details of mike announcement expenditure has not been received in my office so far. Hence the amount shown on this account Rs/-64,626 may be kept in abeyance, pending final settlement of accounts.
- 17. Arch: No amount has been spent for arch decoration. Hence the amount Rs 5,072 /-shown as expenditure on this account may please be deleted.
- 18. Podium: The Inspection Committee has assessed a Rs 46,807/- as expenditure on podium. The stage makers are making this convenience only as part of stage construction and no amount is levied by them for us.

Hence the above amount may please be deleted.

- Defacement: As we have not pasted any poster or notice on any Government building, Rs/-850 shown as charges for defacement is not acceptable to us.
- 20. Food Expences (AT 7 LA): We have been providing Rs 300/- for one person in each of the legislative assembly constituency for daily expenses.

Hence an amount of Rs 3,36,000/- shown as expenditure for 16 days is correct and may be recorded as such.

- Computer and Printer: The amount shown is correct.
- Fan/tube light: No fan or tube light has been hired. Hence the amount shown may be deleted.
- Generator: As the details are awaited, the same will be included at the time of final settlement of accounts.
- Vehicle Decoration: The amount shown is correct.

- 25. Nomination Fee: Since the amount for this has been received as donation, no amount is shown as expenditure by the candidate.
- SMS: The amount shown is correct.

In these circumstances, may I request your good self to provide us with necessary documentary evidences to arrive at correct amount of expenditure. The reconciliation statement of expenses prepared by the Inspection Committee may be revised accepting the actual figures provided by me..
