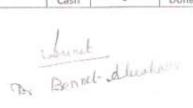

Sub: - Expenditure - notice under section 77 (1) of the Representation of People Act - reply furnishing of.

With reference to the notice mentioned above, I am furnishing the following reply in respect of the details appended to the notice.

- 1. The total expenditure on wall writings (SL. No-2) is disputed. The rate prescribed is Rs 161 paise 46 per M2. At the same time, it is also pointed out that these are done before the nomination of the candidate and we have incurred almost nothing in this respect. The wall writings in most cases are executed by the LDF workers without any remuneration and hence the expenditure if any incurred may be on material cost. Meals or such other personal expenses are the only expenditure that may be incurred by the party/LDF/candidate in this respect. The "Other Expenses" (Sl.No.16) shown with the notice may include this item of expenditure also. If specific details on each wall writing accounted by the officials are made available, we will be able to furnish specific reply as the expenditure shown as official figure is very high whereas according to the registers that maintained with our Assembly constituency level offices these are meagre. Hence the exorbitant expenditure shown against this item may kindly be thoroughly re-examined and removed from the official accounts.
- 2. First of all I may point out that the findings of the Expenditure Observer after his inspection of our Expenditure Register at 9.00 AM on 30.03.2014 are that the total expenditure as per shadow observation register as on 27.03.2014 is at Rs.51,33,621/- as against Rs.20,63,318/- shown by the candidate as on 29.03.2014 whereas the details appended to the notice indicate that as per the details available with the officials, their figure as on 27.03.2014 is Rs.54,94,439 and that of candidate as on 27.03.2014 is Rs.9,65,581 As the official figures itself varies it can be assumed that the figures arrived at are not beyond any errors.

3. With regard to the figures in respect of the posters (SL. No-1), I may invite your kind attention to the fact that there is a wide gap between the printing rates in the presses in Kerala and that in the presses in Tamil Nadu especially in Sivakashi (where printing is a competitive industry). This is evident from the vouchers already filed by us on 29.03.2014. M/s. Colour Track of Kerala has charged Rs.4.00 per piece of poster of 56 x 82 colour in 90 GSM paper, wherein we got 30000 posters printed (voucher 52). Subsequently we got all the remaining posters printed at Sivakashi wherein they have charged only Rs.0.25 for 8.5 x 10.5 size notice (voucher 86), for 21 x 17 size posters (CPI symbol) Rs.1.25 (voucher 84). Anyone can verify these facts directly from the presses at Sivakashi. Hence it may be seen that the figures furnished by us are real.

4. Regarding the expenditure on fluxes (SL. No-4 and 5), it is informed that almost all the fluxes put up are at the cost of well wishers and sympathising organisations of the LDF and the candidate. In this case also the rates fixed by the authorities are exorbitant and are to be revised taking the ground realities into consideration. If the complete details of fluxes fixed in favour of the LDF candidate booked by the authorities are made available, we may be able to check up and furnish the details of actual expenditure incurred by those who arranged such fluxes. In the absence of such details we are unable to agree with the

figures in this regard furnished along with the notice. 5. Expenditure shown on the Committee Office (SL. No-6) is also not actual. We have not floated any tenders or adopted quotation methods to erect pandal, office and temporary constructions etc for party election purposes. PWD rates in this respect are very high, inflated and unreal where contractors, middlemen and others are expected to make high

profit. Hence the figure arrived at may be re-examined.

6. Expenditure on vehicles (SL No. 13) may be a little higher than that furnished by us. We have indicated the real amount.

 All the expenditure booked by the officials as that incurred on behalf of the candidate. before 20.03.2014, the date on which he filed nomination, may be completely avoided.

8. On the whole, most of the figures recorded by the officials are not seems true to the facts. Hence the details may be re-examined and that furnished / to be furnished by us on the basis of real factors may kindly be taken as the actual figures.

1. POSTER

According to the Returning Officer's figure, the expenditure up to 05.04.2014 is Rs.229162/- where as we have already booked Rs.1090627/-.

2. WALL WRITRING

As per the Returning Officer's figure the expenditure up to 05.04.2014 is Rs.3144783/-. As already pointed out the rate prescribed under this head is very exorbitant. In this context, we may point out that almost all the writings were made before 01.04.2014 and are made using lime (Janathacem) and cheap colour powder. Most of the wall writings were done by the sympathizers or by party workers. The total area of wall writing made by us is 10990 sq.m. and we have effected payment of Rs.285740 and the average cost is Rs. 26/- per sq.m. Hence the amount may be reduced to Rs.285740/-

3. CLOTH BANNER

According to our figures, specific expenditure in respect of cloth banner is not booked. However, the expenditure on this item might have been included in "other items" even though proper vouchering is lacked. Considering this aspect, the expenditure booked in this regard by the Returning Officer may be excluded.

4 & 5. FLUX BOARD/BANNER

The rate fixed for this item is also exorbitant. The total amount booked under this head is due to repeated video graphs and due to the fact that the party workers change the flux boards from one place to another for more visibility and to attract public attention. Further, most of the Flux Boards exhibited in favour of the party candidate were arranged at local level without proper information to the candidate/Chief Election Agent. However, the total expenditure in this regard may not come to the figure booked by the Returning Officer. Hence the figure furnished by the candidate may be taken into account as final figures and the amount may be reduced that extent.

6. COMMITTEE OFFICE

As per the figures booked by the Returning Officer, the expenditure on this account is Rs.504000/-. A sum of Rs.116967/- has already been incurred by us as on 5.4.2014. A sum of Rs.216895/- is to be paid further. Thus the total expenditure will come to Rs.333871/- by 09.04.2014. This being the actual figure, the expenditure booked by us may be accepted.

7. FLAG

The expenditure figures booked by the Returning Officer is Rs.21037/- whereas the figures booked by the candidate is Rs.19000/-. Since the difference is negligible, the figures furnished by us may be accepted.

8. DANGLERS

According to our figures, specific expenditure in respect of cloth banner is not booked. However, the expenditure on this item might have been included in "other items" even though proper vouchering is lacked. Considering this aspect, the expenditure booked in this regard by the Returning Officer may be excluded.

Chairs and Tables were hired for using in the Committee Offices and some hall where conventions were held. The expenditure on these items included under that of "Committee Office" and "Conventions". It is also pointed out that the rates fixed for chairs and tables were very high. Considering these facts, the expenditure under this item may be dropped.

11. NOTICE

The figure booked by the Returning Officer is less than the amount booked by us.

12. CONVENTION

The figure in this item booked by the Returning Officer is Rs.294291/-. As per our records the expenditure under this item is Rs. 69569/- Our expenditure is realistic and hence it may be accepted. The difference booked by the Returning Officer may be waived.

13. VEHICLE

The expenditure booked by the Returning Officer is Rs.2043850/-. In this aspect, as already pointed out earlier, most of the vehicles were provided by the well-wishers of the candidate, and the party. Even the vehicles which were given hire charges were provided at a reduced rate. The expenditure on these vehicles was mainly fuel to the vehicle and bat to the crew. This expenditure included under the item "Others/Miscellaneous". Not all the vehicles received permit were put in use. There may be instances were other personal vehicles sighted in the LDF Candidate's reception centres and meeting places were also wrongly counted as that participated in the LDF election campaign.

Further the final settlement will be made only after 10.04.2014. It is expected that an additional amount of about Rs.5.00 lakhs will be there on finalization of the expenditure under this head. Thus the total expenditure on this item may come to Rs.8.00 lakhs till 10.04.2014.

Considering the above facts, it is requested that the vast difference shown in the Returning Officer's figure may be reduced.

14. LOUD SPEAKER

The figure booked by the Returning Officer is Rs.139500/-. Already we have incurred expenditure of Rs.76785/-. Thus the difference is only Rs.62715/-. Since the expenditure booked by us is real it may be accepted and the difference may be waived.

15. FAN AND TUBE LIGHT

This item of expenditure has already been included under the item "Committee Offices". Hence this may be dropped from the figures of the Returning Officer.

16. ARCH

The expenditure booked by the Returning Officer is Rs.10194/-. Actual expenditure is Rs.3800/-. This may be accepted and the difference may be waived.

As already mentioned above, some items of expenditure incurred on the above heads are included under the item "Others" even though specific vouchers are lacking. One reason for this non-inclusion is that area level arrangements were made locally and informally and specific vouchering was not done at that level. Anyhow, all the expenditure incurred in the constituency for the LDF candidate has been included by us.

In these circumstances, I request you to consider the matter favourably and to please order to reduce the amounts as required above.
