As per the directions in the reference cited, You have lodged your final accounts. On verifying the final accounts, following discrepancies are noticed.

I. In schedule 1 of the abstract statement no entries are made in respect of the public meeting conducted by you which is accounted in the shadow register.


II. On verifying schedule 5 of accounts, the amount booked in respect of charge of usage of vehicles is Rs.43,600/- whereas the amount charged for the above items in shadow register is Rs.60,750/-

III. In the Bank account statement total withdrawal is seen as Rs.1,65,047/- whereas total expenditure shown in part II of the abstract statement is Rs.1,50,100/-

IV. Voucher numbers are not mentioned in the expenditure register.

V. The vehicles permitted 1) KL 36 A 3555, 2) KL 13 V 8895, 3) KL 13 C 5173 and 4) KL 58 4096 are not seen accounted in the final accounts.

Hence, a reply may be furnished to this office within 48 hours, explaining the reasons for omission or default which are detailed above. Where no reply is submitted by you or your election agent within 48 hours of receipt of notice, then the suppressed amount mentioned in the notice shall be treated as final and the same shall be added to your election expenses.
