

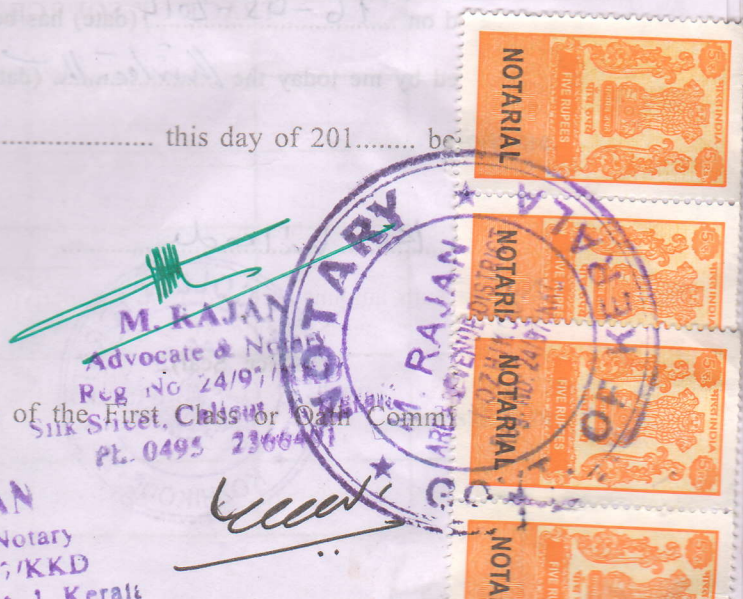


Sub: General Electaion 2014 – Statement of Expenses – Explanation submitted

Kindly see the notices cited wherein I am called upon to explain the differences in the expenditure amount booked in the shadow register and the figures submitted by us. The inspections on 01-04-2014 and 04-04-2014 identified amounts of ₹ 7,38,581/- and ₹ 7, 88,433/- respectively as difference.

I may submit that the differences occurred due to the fact that several bills relating to advertisement materials and audio facilities have not been settled. Since the institutions doing these works usually settle their bills in installments. So there is bound to have difference in the shadow account and that maintained by us.
