Sir,

Sub: notice issued about the difference in the expenditure submitted by us and the shadow registers maintained by the election commission.

There is a difference of Rs 11,739.30 in the amount shown in our account register for public meeting rally etc in (a) this has happened because two are voluntary and free services by our workers and sympathizers for conducting public meetings and processions. So the difference of Rs 11,739.30/- is not ~~any~~ <sup>to any</sup> full omission on our part.

In the 11 part of the register there is a difference of Rs 5,10,274.00/- with the amount shown by us, this has happened not because of any omission or concealing by us but because a good part of our campaign was done by our workers and sympathizers by way of free service and voluntary help. The bills produced by us show the actual amount spent by us by way of paid services and there are no other amounts spent by us.

P.T.O

In IV part there is a difference of Rs 164,277/- with the amount shown by us as spend on campaign vehicles, the amount shown by us is: 395,420.00/- is the actual amount. Spend on vehicles which were used in campaign, though we had ~~taken~~ permission for using more vehicles than those shown in the account register produced by us we had only used those vehicles shown in the register, the difference may be due to the said fact.

In part V the amount shown in the register maintained by the election Commission is 690,009 but we have not shown any amount in the said head, this is because we have not spend any amount on our workers and agents, our workers and agents had worked for our candidates free of cost or expenses they had done voluntary work and we had not spend any amount for them.

In part VI there is a difference of 12,365/- with the account produced by us and the shadow register, the amount of Rs 57,038/- shown by us is the total of the deposit amount and the deputation charges of Rs 28,953 and tea expenses of Rs 3085/- we had only spend the said amount on this head, all other work done by our workers as part of any other method of campaign was voluntary and free service. So the amount shown by us is actual.
