

I have recieved your notice on the above subjects at the close of office hours on 17 June **2014**, seeking explanation for the difference of rupees 1689296/- between shadow register and **the** expenditure register.

In this regard I give below the following explanation as per your notice.

SI No. I. Expenses in public meetings, rallies, processions, etc..

I have spent only rupees 501650/- in this head. In many centers the mike sets, chairs, **tables** and other necessary items for public meetings, rallies etc. were erected and arranged **voluntarily** by the cadres and sympathisers our party. So I need not have spent any money in this regard. Shadow team might have accounted as expense for these voluntary services and hence this difference of rupees 165043/- which may be condoned.

SI.No: II. Campaign material other than those used the public meeting......

I have accounted the actual expenses incurred by the LA wise committees in this regard. All the centres where those wall writings, the essential materials like paints, brushes, etc were provided by us and the work is done voluntarily by our artists as their political commitment. Similarly the cutouts etc. were also erected in various centres through the voluntary work. The shadow team might have calculated the expenses of these displays according to the standard hiring rates and hence the difference of rupees 169062/- more appeared in the shadow register. but my actual spending on these items is rupees 3727931/- only. So I request you to condone this difference.

Sino. IV. Experionure on campaign vehicles.

There appears a difference of rupees 705584/- in this head. We have taken permission for vehicle passes from RO and AROs and have accounted 61 such vehicles used for the electioneering in seven LA segments for the use of different dates. But the actual use these vehicle in most of the cases are done on a later dates. The shadow team might have accounted the expenditure from the date of issue of the permits. In some LAs we have taken permission for more number of vehicles. But due to the scarcity of fund we have not used a good number of vehicles and have not accounted these unused vehicles. In some cases permission taken from RO were used the whole of the parliamentary areas, which might have counted LA wise by the shadow team which may lead to the multiple costing of expenditure.

All these factors have lead to the difference of rupees 705584/- on the head of vehicles. The actual expenditure on this item is included in the account and therefore request you to condone the difference on the basis of above explanation.

SI.No.V. Expenses of campaign workers and agents etc...

We have conducted our election work by voluntary services of thousands of workers throughout. They are not paid any remuneration for these voluntary services on the date of polling my polling agents were posted in all polling booths all of them were from the same booth areas and performed their duties voluntarily. Similarly on the date of counting my counting agents were also done their duties voluntarily. So on these counts I have not spent any amount. All the work of booth agents, counting agents, chief agent and expenditure agent have performed their duties voluntarily true to their unflinching commitments to the political faith. So I request you to ignore this hypothecated expenditure shown in the shadow register under the head of expenses on campaign workers.

It may be noted that an amount of rupees 34430/- towards boarding charges, food, and travelling expenses of counting agents in connection with counting of votes on 16th May 2014 was outstanding to be paid.

Considering the above explanations I request you to accept my statement of election expenditure as shown in the expenditure register and abstract statement.
