Report on the Audit of the Financial Statements

We have audited the accompanying Receipt and Payment Account of Communist Marxist Party (CMP) – Central Council for the year ended 31st March 2023.

Management's Responsibility for the Receipt and Payment Account

The responsibility for the preparation of the Receipt and Payment Account lies with the Central Council of CMP. In making those risk assessments, the auditor considers internal control relevant to the preparation of the Receipt and Payment Account. An audit also includes evaluating the appropriateness of the accounting policies used and the reasonableness of the accounting estimates, if any.

Scope and Limitations

Our audit was limited to the verification of transactions recorded in the Receipt and Payment Account of CMP – Central Council, based on the bank account maintained with Dhanlaxmi Bank Ltd., Mancaud Branch, Trivandrum and the related books and records provided to us.


