Filing of Claims / Objections

In case of any elector is unable to submit their filled enumeration forms within the specified time, they may file **Form 6** along with the prescribed declaration form for inclusion during the claims & objection period (**23.12.2025 to 22.01.2026**).

Form 6 – Inclusion of Names.

Form 6A – Inclusion of overseas electors.

Form 7 – Deletion of names due to death, shifting, duplication, etc.

Form 8 – Correction of particulars, change of address within the constituency, and other updates.

Appeal Provisions

If a person included in the draft roll is excluded after the hearing, a first appeal can be filed before the District Election Officer (DEO) within **15 days** of the order of the Electoral Registration Officer.

(Under Section 24(A) of the Representation of the People Act, 1950 and Rule 27 of the Registration of Electors Rules).

A second appeal can be filed with the Chief Electoral Officer within **30 days** from the date of the first appeal order.

(Under Section 24(b) of the Representation of the People Act, 1950 and Rule 27 of the Registration of Electors Rules)

Citizens are encouraged to make full use of this review window to ensure accuracy in the roll.
